9:02:35 AM Tammy said that she had given this resolution to Weston who did not see any issues. Have the van that is out in the parking lot that was donated from the Supreme Court. This is maybe driven once a year and is a drain to her budget having to maintain it. Felt with Mitch getting the bid website going that this would be a good opportunity to put this on the website. Thought to have a starting bid of \$1,000. Looked through Bluebook and it was \$1,000 to \$2,200. Weston wanted her to make sure they knew this needed advertised and she realizes that this will need to be advertised.

9:10:03 AM Tim wanted to come by and remind them of the contribution they would like to make to the county and see what they had decided. Chairman Farnsworth said they will be looking at using this at the lake and having a park bench with their name on this. Wanted something that would stick around. Tim asked who he should work with. Chairman Farnsworth said it will be Mickey. Tim hands out a service report. (Exhibit A) 9:11:38 AM Tim goes over he covers about eight counties in his region. Total contributions to Jefferson County since 2014 from the foundation is \$23,000, direct contributions are \$4,400, sponsorships are \$9,600 and in-kind work of \$3,500 for hanging Christmas lights where small counties do not have a bucket truck. Total about \$40,500 this is through 2017. Basic facts they serve 11,612 customers here. Last year delivered 403,937,387kWh. Property taxes paid \$374,659.

Tim is not sure if they are familiar with franchise fees. In Idaho all cities have franchise ordinances. At least for electrical utilities the cities can request a franchise fee under state statues to pay back to the cities for being in their town. These can be different rates. Dubois charges ten percent. Rexburg charges six percent. Ucon charges three percent. Four cities and towns where they collect these. Periodically they will audit these towns. Have them check to make sure all the annexations are all listed. Lewisville remitted in 2017 \$3,720.43. Mud Lake remitted in 2017 \$4,978.28. Rigby remitted in 2017 \$99,671.86. Ririe remitted in 2017 \$12,783.37. Total with all four is \$121,153.94. Regional contributions in 2014 was \$58,100, 2015 was \$69,050, 2016 was \$50,790 and 2017 was \$43,300 for a total of \$221,240 contributed since 2014 across the region.

9:56:22 AM Jay Hill comes up. Had an experience this morning 89.9 at 6:00 this morning. There were two of them that called the Sheriff's Office. Since the last meeting they have put a lot of money into this facility. Believes this is what has added to the increase of hours. Working twenty-four hours a lot of nights. Still working at 1:00 or 2:00 in the morning. Having deliveries on Sundays and the middle of the night. Truck drivers will pull in from Saturday until Monday morning. Got a 90.2 reading off of the semi while standing on his side of the fence. Noticed the gate to the facility was open went and asked them to move the semi this was at 11:15 at night. Have had numerous calls to the Sherriff's Office since the last meeting. Plays a recording from cell phone from May 15. This is their life. Listen to this all the time. Has been a year and over a month since the April 24 meeting and almost a month from the May 7 meeting. Came back in to see where the county is at with this. They cannot even use their own backyards.

10:06:09 AM Chairman Farnsworth spoke with Planning & Zoning this morning. Have been putting a file together. Have google photos with how this has changed over the years. Kevin said he has this ready to go in the next few days to the Sheriff's Office and Prosecutor's Office.

Tom O'Reily asked if a letter was ever sent. Weston said that this would be a letter sent once they were able to move forward. Tom said they challenged this in previous meetings that if they are out of their zoning and the county suggested sending a letter.

10:07:35 AM Chairman Farnsworth said the whole thing will be going to the Prosecutor in the next few days. Jay asked how much time once the Prosecutor gets this. Paul Butikofer said the first move will to screen for any criminal prosecution then would need around thirty days. Jay asked if the powers attached to the zoning laws and the responsibility of the commissioners. Paul said they will screen this once they receive the report. Jay said the noises are harmful and dangerous. Up in the hearing loss range. Ward Whitmore said OSHA guideline is 85 decibels. If exposed to this more than eight hours a day then they need wear hearing protection. Weston asked if they contacted EPA. Jay said they paid for a subdivision to go over EPA laws. This money was no longer funded so they do not have any way to enforce this. Weston asked if they are asking local authority to enforce a federal law.

10:10:23 AM Jay said in a previous meeting he went over that the federal government would be responsible for high level things. Then county and city law would take care of the rest. Some have enacted noise ordinances but we do not have anything in this county. Asking to enforce the nuisance law. Ward said they are not asking to enforce federal law. Want them to enforce the county zoning and nuisance law. "Nuisance is anything which is injurious to health or morals, or indecent, or offensive to the senses, or an obstruction to the free use of property, so as to interfere with the comfortable enjoyment of life or property is a nuisance." It may be complicated how they deal with this but this is not.

10:12:13 AM
Paul said that his office has not received anything yet. Ward said they have given statements, petitions and the Sheriff's Office has come out numerous times. Really angers him when he is trying to watch TV. Lives on the other side of the river they are a quarter of a mile away. Deputy Roberts came out and he was stunned with how loud it was out on his deck. Coming across this plant boundary is a lot of noise. When they get evidence that the decibel reading is over the OSHA guidelines. Jay said EPA maximum is 55 decibels. Provides a copy that describes the decibel reading. (Exhibit B) Had an 89.9 reading this morning on his decibel reader.

10:15:19 AM Ward recognizes they have not received the information. Have addressed the nuisance. Cannot comprehend that this is not in violation of zoning. Goes over the light industry this is to serve the community. Received a US legal definition of light industrial and legal definition. "Light industry refers to manufacturing activity that uses moderate amounts of partially processed materials to produce items of relatively high value per unit weight. Light industries require only a small amount of raw materials, area and power. The value of the goods produced is relatively low and they are easy to transport. Light industries cause relatively little pollution when compared to heavy industries. As light industry facilities have less environmental impact than those associated with heavy industry zoning laws permit light industry near residential areas. It is a criterion for zoning classification. The manufacturing of clothes, shoes, furniture, consumer electronics and household items are a few examples of light industries." (Exhibit C) The zoning law is absolutely clear. They are putting out a noise level of 89 decibels they need to look at the OSHA regulations. Not asking them to enforce federal regulations. The question to follow up is there any doubt they are not within their zoning. Has been over a year since they started coming in. To him and a lot of them they are waiting to see what they will do.

10:20:13 AM Jay said this effects over 200 people. Spoke with Kevin who had talked with Challenger and they said they have increased their business. This does not resemble what was there before the fire in 2006.

10:21:01 AM Tom asked on the reports they are waiting for from Planning & Zoning is the nuisance complaints. Paul said they take this in priority crimes are first priority once they get this from the Sherriff's Office. Have met with both Kevin and Captain Wolfe. Captain John Wolfe has been in charge but have not received a final report. After they make that determination then they will look at the zoning part. Jay said that could be a misdemeanor. Weston said they will screen this against the county ordinance. Tom asked if Planning & Zoning does not have enforcing authority. Paul said they get the information from the Sheriff's Office who get it from Planning & Zoning. Tom said they are operating outside of the zoning but it may not rise to a criminal action. Typically a zoning department has the authority to enforce the zoning without going through the Prosecutor. Could go tell the facility they are operating outside of their zoning and what they need to do to be within the zone. Chairman Farnsworth said they now have a compliance officer. Tom agrees with what they are doing but it is obvious they are outside of their zoning. Records from permits have stated that when these were applied for this was for warehousing. Now this should be considered manufacturing. From the zoning standpoint would like the zoning department to go in and bring them into compliance.

10:25:20 AM Chairman Farnsworth said a couple of days Kevin will turn in what he has found. Are willing to do whatever their legal department tells them they can do. Knows they are passionate about this have listened to all of their testimony. Ward mentions that Bill Smith could not be here today he sent a letter to Planning & Zoning asking for permits and who signed this. Kevin said he got an email. Ward said some concern is this facility is owned by a former commissioner who should know what the zoning is.

10:28:29 AM Jay said to finalize this would like to feel a sense of urgency. If they lived by this they would understand. Have provided the Sheriff's Office and Planning & Zoning with a lot of documentation. This has been tougher and tougher to put up with this. Chairman Farnsworth asked that Planning & Zoning and the Prosecutor move on this as guickly as they can.

Will have monthly safety meeting tomorrow morning and him and Ted will interview for the mechanic position. Will start back on 3500 all the way to County Line. Will not be able to get hot mix from HK until after July 4. Struck a deal with Depatco for the same price a longer haul but they will have to get through this. Chairman Farnsworth asked if they are doing prep on other roads. Dave said on 3800 to make the widening work it will take some effort. Commissioner Martinez asked if they had any seasonal applicants. Dave said he only had two applicants that have already received jobs. Was considering hiring Wendell Barnes but he can only work nineteen hours. Would pay him at his previous rate. Dave said this is a sign of the economy.

10:34:06 AM Chairman Farnsworth said they will finish 3500, then the lake road, then go to 4100 and back to 3800. Dave said HK is unable to provide hot mix because they have a big project on Highway 33. Taking the old bridge out this is single lane being operated by a signal light. Chairman Farnsworth asked what would be after 3800. Dave said 4225 out in Labelle. Working on a few issues will need a zipper working with Teton County. Already indicated we could use this. This would be used out on 500. Also on the railroad crossing on 4000 E. After that will pause and do chip sealing on all of the roads that were paved last year. Chairman Farnsworth said they have 3500 then lake road, then 4100, then 3800, then 4225, then 500 and railroad on 4000 E.

10:38:07 AM Chairman Farnsworth said there is a ditch on 500 that floods clear across the road. Dave said he received a text and pictures on this last night. Chairman Farnsworth thinks the farmers may need to do something this floods every time they irrigate.

10:40:03 AM Chairman Farnworth said that 3500 is almost done. Commissioner Hancock asked if the leveling course will be adequate. Chairman Farnsworth asked if they did the leveling course then chip seal this. Dave said they are trying to get a foot wider in each direction. 4225 will be one like this.

Commissioner Martinez asked if George is out patching. Dave said he is out fixing holes. Tomorrow will be focusing on the lake road to get this patched up prior.
